Rideau Street Sinkhole - Relief Event Subsequent Notice

Dear Mr. Estrada,

This letter follows our previous letter no. OLR-RTG-10-2-LET-0477 dated June 14, 2016 with regard to the above mentioned subject and shall constitute a subsequent notice as per PA Section 43.3(d).

On June 8, 2016, at approximately 10:15 AM, an incident occurred near the corner of Rideau Street and Sussex Drive which involved a ruptured City water main and water infiltration, and a 25-meter diameter sinkhole was created at the street level. The cause of this infrastructure failure is being investigated at this time.

The Relief Event that occurred on June 8, 2016 has caused failure to OLRT-C, and thereby Project Co, to perform its obligations under the Project Agreement as it is preventing OLRT-C/Project Co to perform and complete the Design and Construction Works in accordance with the Works Schedule and in accordance with the other terms and conditions of the Project Agreement pursuant to PA Section 20.1(a)(iv) and (v). As a result of the Relief Event, OLRT-C, and thereby Project Co, will be unable to meet the Scheduled Milestone Acceptance Dates associated to Milestone #7 (Completion of Tunnelling) and Milestone #8 (Tunnels – Post Excavation). This Relief Event may also impact Milestone #10 (2017 Readiness) as well as the Required Revenue Service Availability Date.





Pursuant to PA Section 43.3(a) and given the criticality of the Rideau street sinkhole, OLRT-C is taking commercially reasonable steps to mitigate "without prejudice" the consequences of the Relief Event and to remedy the situation promptly and diligently. Assuming we are resuming tunnelling activities within the next few days, OLRT-C is anticipating a 3-month delay. At this time, OLRT-C cannot estimate the period of time required to overcome the Relief Event and/or its effects.
